Abstract / Objectives

- _ Identifying a new social reality with different forms of family life along with the existing prevalence of traditional patrimonial regimes;
- _ Comparing national legislative models and solutions based on traditional property transmission patterns and underscoring the difference with the new approach;
- _ Collecting and analysing the available data, including those of intra-EU families and those of extra-EU families;
- _ Providing a collection of contract models that can be used in family property and successions matters;
- _ Creating a website to spread the results of the analysis of the collected data and to offer various materials including a downloadable multilingual handbook;
- _ Creating a network of institutions that are leaders in the best application of the EU family and successions legislation and that share cases and issues among themselves through a specific electronic platform.
