# Short biography

MATIJA MILOŠ is a teaching and research assistant at the Chair for Constitutional Law of Faculty of Law in Rijeka. He holds a degree in law from the same institution. He started his postgraduate studies at the Central European University (CEU), where he graduated from the Legal Studies Department, Comparative Constitutional Law program, earning an LL.M degree with distinction. In January 2019 he defended his doctoral thesis on direct democracy at the Faculty of Law in Zagreb.

At the Faculty of Law in Rijeka, Miloš teaches constitutional law and law of non-profit organisations. He is involved in teaching within several programs of the Faculty, specifically the Integrated undergraduate/graduate university Study of law, the Undergraduate Professional Study Programme in Administration Studies and the Specialist Graduate Professional Study Programme in Public Administration. His work receives consistently high grades in student evaluations. In his research, Miloš primarily dealt with constitutional theory. He has published on a variety of research interests: religious freedom and the secular state, freedom of expression, right to (bodily) privacy, direct democracy and legal aspects of political representation. In his current work, Miloš investigates the relationship of time and the constitution. He is a regular participant of international conferences and is a member of the Central and Eastern European Regional Chapter of the International Society of Public Law.

University of Rijeka awarded Matija Miloš for his work as a lecturer in the academic year 2015/2016. Miloš also received an award for his paper on the right to be forgotten in 2015. Other than working at the Faculty of Law in Rijeka, Miloš cooperates with civil society organisations, having taught antidiscrimination law in a project organised by them. He is currently representing the Faculty of Law in establishing an interdisciplinary course at the University of Rijeka which would allow students to gain practical experience in running projects with local civil society organisations.
